### B. Approval of February 17, 2022 Minutes

Comm. Sexton made a motion to approve the minutes. Comm. Berg seconded. The vote to approve was unanimous.

### C. Continuing discussion about 2022 Historic Preservation Month

#### E. Items from the Commissioners

The County's Natural Areas, Parks and Events Department requested a support letter for a grant they were applying for from the Historic Preservation Fund; Housing and Urban Development (HUD) Economic Development Initiatives (EDI). The purpose of the grant is for the seismic retrofit of the courthouse.

The commission discussed term expirations. A commissioner who joins in the middle of a term, the terms do not start until the first full term. Comm. Taniguchi is set to expire in 2024. She mentioned that Mark Forbes is perhaps interested in applying. He and his wife own the Mark Rickard house.

Commissioner Sexton mentioned that he might be elected as the state president of the Oregon grange. This will mean he will be busy three days a week and on the weekends. He hopes he will still have bandwidth to stay with the HRC.

Comm. McClure wrote a letter for the courthouse grant. Nancy is going to send it to everyone to review, then sign it and get it Lynne McKee with the Parks Department.

Comm. McClure said he went out to the Hoskins Farm with Autumn Peterson to look at the barn. It is in bad shape. Autumn was trying to work out a deal to see if she can salvage the material. The south side of the house looks a little worse for wear but the family is still living in it.
