

The duties of Benton County's Disposal Site Advisory Committee (DSAC) are outlined in Oregon state law—specifically in ORS 459.325, which includes the requirement that "the committee shall prepare an annual written report summarizing the local citizens' concerns and the manner in which the owner or operator is addressing those concerns" which will be considered by the Department of Environmental Quality (DEQ) as part of issuing and renewing a solid waste permit.

Benton County staff and the DSAC have prepared the following staff report summarizing community member concerns regarding Coffin Butte Landfill in 2023, which may be used by DSAC to meet the requirements of ORS 459.325. Concerns listed in this report have been compiled using information from the Coffin Butte Landfill & Pacific Region Compost Annual Report 2023, comments made at Benton County Talks Trash meetings, complaints received by Benton County staff, complaints received by Republic Services, the Oregon DEQ and concerns presented during DSAC meetings.

One hundred twenty-two complaints about the Coffin Butte Landfill were reported in 2023 as detailed in the table below. Some complaints included numerous topics while others focused on a single concern. The complaints were organized into themes as illustrated in the following pie chart.

The complaints received by Benton County directly were fairly evenly distributed by topic, with odor complaints as the single topic with the most complaints. Odor complaints were one third of all of the concerns reported. In response, Coffin Butte Landfill has reported that it has expanded its methane capture system to reduce fugitive gasses from escaping. Complaints categorized as "Other" were largely comments on the Benton County Talks Trash process, service complaints and people reporting their opposition to the landfill expansion.

Since DSAC is still not meeting in its function to provide a forum for local residents to reports incidents and to promote a dialog with the landfill operator on addressing these problems, I am ccing Julie Jackson on this so that she can direct these complaints to the responsible individuals in the company. 1. Garbage flying out of truck on way to landfill: Today (5/22/20123) at 6:21 AM a northbound Republic Services truck with a large construction-type dumpster was shedding plastic bags along Hwy 99W, near the south end of Arboretum Road. After seeing at least 5 bags fly out as I approached the truck (I was headed southbound), I gave a horn blast in an attempt to alert the driver to what was happening, but the driver just kept going north at highway speed. That truck would have arrived at the scale house within a few minutes (by 6:25 AM) so perhaps scale-house records could be used to follow up with the driver. Though this type of thing happens regularly, and this is not the only Republic driver failing to secure a load, so preferably the company will take more systematic action in training drivers and checking that the load-covering systems are functioning properly. 2. Blown tire from garbage truck left in lane of travel Earlier last week (I did not note the date or time but VLI phone logs should have a record of this, I think it was 5/17), a southbound Republic Services truck (the type used for residential garbage pickup) blew the tread off its tire right in front of our house. It made a tremendously loud bang like a bomb going off. I looked outside in time to see the truck which had slowed down in front of our neighbors' house to the south, but then it sped up again and left the scene. When I ran out there I found a full tire tread was left out on the roadway, in the lane of travel for passenger cars which were having to go into the left-hand lane to avoid it, so posing a hazard for regular traffic	Written comment	Email	Daniel acknowledged the complaint and followed up with resident.

shoulder, then immediately called VLI's office to report the incident.

After that I had to run some errands in town, and noticed that there was a trail of shredded strips of rubber -- many with sharp wires projecting -- all along the southbound shoulder of the road as far as the south end of Arboretum Road. The county (or ODOT?) just recently run a street-sweeper along the highway, and over the weekend I had also seen a local volunteer out picking up trash near the south end of Arboretum Road, so this was new debris. Since the shoulder of Hwy 99W also functions as a bicycle lane, this type of debris poses a hazard to bicyclists.

Someone did come out and pick up the main section of tread by the time I returned from town, so thank you to whoever did that. However they didn't pick up the long trail of tire fragments along the shoulder to the south.

Tire blowouts are also fairly common thing with trucks heading to and from the landfill. If this were to happen while a truck is passing a bicyclist or pedestrian along the highway, there could be a severe injury or even fatality. Republic Services, VLI, and the various commercial haulers should be more responsible in checking that truck tires are properly inflated and in good condition, and that trucks are not overloaded, since those conditions contribute to blowouts.

There should also be driver training on what to do in the event of a blowout. There can be no doubt that this driver noticed the enormously loud explosion, so they should have stopped to address the problem (removing the hazard from the roadway and changing out the blown tire to avoid creating further hazards). Does Republic's company culture promote responsible behavior in such situations? Or are drivers so worried about keeping to their schedule, that they feel pressure to keep rolling?

3. Dump odor event on Saturday

Saturday morning was a bad one for sulfurous landfill stench in Soap Creek Valley. I happened to be over there for a project monitoring endangered grassland birds, and noticed it as I was driving home, even with the windows rolled up. There were also visible clouds of dust coming off the landfill from the tipping area. I have filed an odor complaint with DEQ.

4. Garbage left exposed in tipping area after Saturday

		A wide patch of garbage on the south face of the landfill was left uncovered after operating hours on Saturday evening, and all day Sunday. This was clearly visible from half a mile away on Camp Adair Road.			
		Leaving garbage uncovered outside of operating hours is a problem not only in terms of odor, but also because it attracts scavengers. On Sunday I counted 14 ravens and 4 eagles scavenging in the exposed garbage. Ravens are nest predators for many songbirds including grassland birds such as meadowlarks, and eagles prey on Great Blue Heron nestlings (possibly a factor that led to failure of the heron rookery on VLI property last May).			
		Again, this is a recurring problem, though not always reported. I believe it is out of compliance with the conditions of approval for VLI's operating license, so we should expect better diligence from VLI/Republic on this.			
		I'll appreciate if you can add these items to the record of landfill-related issues.

Concerns over such waste were among the reasons why SWAC and DSAC members (prior to the suspension of both, and the eventual dissolution of SWAC by the county commissioners) had been calling for an audit of waste coming to the landfill from out-of-county.

So here are my questions:
Question 1: Has Benton County received any
notification of prohibited medical wastes such as
syringes being found recently at Coffin Butte
Landfill?

This issue might become more acute with the passage of Oregon Senate Bill 488, which was passed and signed into law by Governor Tina Kotek at the end of the last session. Question 2: Recently you mentioned an "inspection" of the landfill that you were trying to schedule with the landfill operators. What was the focus of that inspection, did it happen, and what did you find?

Question 3: Has Valley Landfills Inc. (or Republic Services) delivered their 2022 Annual Report on the landfill to the county, and if so, can you please make that publicly available on the county's solid-waste management web page?Question 4: Did Valley Landfills Inc. (or Republic Services) share their 2022 Annual Environmental Monitoring Report (as filed with Oregon DEQ) with Benton County, and again, if so, can you please make that publicly available on the county's solid-waste management web page?

Although some of these questions should properly be taken up by DSAC, I note that DSAC still seems to be suspended de facto, as there have been no meetings in over a year, and no meeting is yet scheduled for September.

So please consider these as questions from a concerned Benton County resident and landfill neighbor, whose legitimate interests are currently not being represented by a Disposal Site Advisory Committee, despite the clear stipulations of Oregon statute.

EPA INSPECTED THE DUMP IN JUNE 2022 AND FOUND MASSIVE METHANE LEAKS THAT VIOLATE AIR OUALITY LIMITS. Methane is an odorless gas, but it is not the only air pollutant spewing from the dump. On Highway 20 at Independence Highway on Friday December 15 around noon, the smell from the dump was absolutely overpowering. Residents are being exposed to toxic air pollution from the dump, and people living in and around Adair Village, Logsdon Ridge, and North Albany know exactly what I am talking about. EPA FINDS MASSIVE METHANE LEAKS AT COFFIN BUTTE LANDFILL The EPA performed an ANNOUNCED clean air inspection of Coffin Butte landfill on June 23, 2022. This means that EPA TOLD THE DUMP OPERATORS in advance that EPA was coming to conduct an inspection. For background, SEM stands for Surface Emissions Monitoring, PPM is a measure of concentration and stands for Parts Per Million. Under its Air Quality Permit, Republic Services is allowed to self-monitor gas emissions from the landfill.

While EPA found dozens of methane concentration exceedances, not surprisingly, Republic's self-monitoring reports only found very few exceedances and some reports didn't find any. Methane is one of the most potent greenhouse gases. Landfills that are emitting tons of methane are also emitting many other air

pollutants. Coffin Butte landfill is one of the largest methane emitters in Western Oregon. Information presented here is excerpted from a 14-page EPA report dated September 19, 2022. Daniel Heins, the EPA inspector, spent nearly 9 hours on site during the inspection. The EPA surface emissions monitoring inspection found: : EXTREME METHANE LIMIT EXCEEDANCES: Quoting from the EPA report, "Over the course of the day, Daniel Heins identified 61 POINTS IN EXCEEDANCE OF 500 PARTS PER MILLION (PPM), EXHAUSTING HIS SUPPLY OF MARKING FLAGS. Of these, 21 flagged exceedances were ABOVE 10,000 PPM. Many flagged exceedances represented clusters of exceedances at multiple points or BROAD AREAS OF EXCEEDANCES. Of the flagged exceedances, 26 were at or partially at gas collection wells (including both active and abandoned or decommissioned). Eight exceedances were at leachate cleanouts. Daniel Heins focused monitoring on areas under intermediate cover, though the first six exceedances were in final cover areas. During the afternoon monitoring, Daniel Heins measured MULTIPLE EXCEEDANCES THAT CONTINUED TO BE ABOVE 500 PPM MULTIPLE FEET IN THE AIR, with multiple feet lateral distance from the emission source, INDICATING SUBSTANTIAL LANDFILL GAS PLUMES." DISCREPANCIES BETWEEN REPUBLIC'S REPORTED MONITORING AND WHAT THE EPA FOUND: Again, quoting directly from the EPA inspection report, "Daniel Heins expressed potential concerns with Republic's SEM/Method 21 procedures. Despite Republic having seen no more than 6 exceedances in the recent SEM reports supplied ahead of the inspection that included penetration monitoring, including reports with 0 exceedances, he identified 61 points in exceedance of 500 ppm, including 21 points above 10,000 ppm, with 26 exceedances at gas collection wells that Republic should have specifically been monitoring on a quarterly basis since the Oregon State Plan became effective in November 2020." "Daniel Heins expressed concerns with the areas of tarp that were inflated with and leaking out landfill gas, as detected during the SEM, noting that in additions to compliance concerns with the surface methane standard that such an accumulation of flammable gas creates a potential safety concern." In my opinion, the response from Republic Services proves that they are outright lying by daring to negate the very real experiences of those of us living in the area. It is my further opinion that if Republic Services produces logs or reports showing nothing unusual or amiss, those are likely being falsified, as it is patently illogical to believe that the methane emissions could have grown exponentially in the last year if everything were as it should be. They are clearly operating in CYA mode (Cover Your A**). That is why everyone has begun reporting complaints directly to the government agencies now, rather than to Republic Services, as R.S. have proven themselves untrustworthy in these matters.

I am forwarding the following emails in an effort to ensure that Senator Wyden and Senator Merkley are informed of the ongoing, ever-increasing emissions, odor and mismanagement issues continuing at the Coffin Butte Landfill site in Benton County, Oregon.

I received an email from Oregon DEQ representative Laura McWhorter, in which she attached a response from Republic Services Environmental Manager Paul Koster. The responses are incredibly superficial and insufficient to address the odor and emissions complaints. This is gas-lighting at its best. I believe Republic Services and its agents are misrepresenting the truth either outright or by omission, because the odor has indeed increased exponentially this past year, and has reached levels of intensity that have caused me nasal and throat issues if I have lingered outside too long while trying to take care of necessary tasks on my property near the landfill. The odors are also often strong enough to permeate indoor structures that don't have air filtration systems in place. That has been happening throughout the fall and winter, and as recently as this past week in January of 2025, well after the landfill's supposed steps to mitigate emissions leaks exposed in the June 2024 EPA inspection. As someone living within a mile and a half of the landfill, I can attest the problems have only worsened since the inspection. They have certainly not improved.

Please ask Senators Wyden and Merkel to help protect our community from the environmental harm being perpetrated by Republic Services. I also beseech them to hold Oregon DEQ and Benton County agencies accountable for what at this point can only be considered informed complicity in allowing the Coffin Butte Email

This email went to the DEQ; and Senators Jeff Merkley and Wyden and Hoyl

Bailey responded by letting them know how to record complaints with Benton County, how to provide public comment to the DSAC and how to the Planning Commission.

Coffin Butte Expansion

We are extremely concerned about Republic Services' attempts to expand Coffin Butte landfill.

This proposal is not in accordance with the Principles as defined in the **2040 Thriving Communities Initiative** which values:

- -<u>Vibrant, Livable communities</u>: A landfill makes a mockery of the "vibrant, safe and livable community" which we should "strive to ensure" and is not "forward thinking". We should be implementing more long-term solutions for waste, including reducing the production of single use items and the expanding of recycling and reuse programs.
- -<u>High Quality Environment and Access</u>: The landfill will be a toxic, environmental hazard for decades to come. Even if the existing standards, as defined by DEQ and state and local requirements, were enforced, (which is currently not the case) the plans proposed by Republic Services (including no cap on annual tonnage brought in) will only make matters worse. The current and future air, soil and water quality issues will not be resolved without enforcing current standards and limiting future expansion.
- -Community Resilience: "Recovering from human caused disasters, threats and changes" is of course critical. But should we not also be preventing, or at least minimizing human caused disasters such as this land fill and Republic Services' disregard for sited emissions violations, methane leaks, PFAS dangers and pollution of the Willamette River?

<u>Violations of BCC 53.215.1-</u> "Interference with uses of adjacent property"

The far-reaching odors from the landfill site and the noise and destruction of Coffin Butte are ruinous of property values and make the EE Wilson Wildlife Area virtually unusable for recreating on many days.

<u>Violations of BCC 23.325.2</u> – "Imposition of undue burden on public improvements, facilities, utilities or services"

Heavy truck traffic to Coffin Butte drastically increases deterioration of our roads, leaves roadsides strewn with debris and creates more tailpipe emissions near homes and schools.

Leachate from Coffin Butte is dangerous to ground water and soil, creates even more truck traffic, burdens our water treatment facilities and pollutes a major recreational feature of the area, the Willamette River.

Please DO NOT LET THIS EXPANSION PROCEED!

Republic Services Submits Additional Materials for Conditional Use Permit Application

January 17, 2025

Republic Services has submitted supplemental information for its Conditional Use Permit (CUP) application to Benton County. The CUP application was received by Jan. 15, 2025, meeting the deadline required by Benton County Code.

The pre-application drafts are available online in their entirety through <u>Munidocs</u>. The supplemental material submitted on January 15 can be <u>viewed and downloaded from the Benton County website</u>. A printed copy of the application is also available for viewing in the Community Development Department on the second floor at 4500 SW Research Way in Corvallis.

The CUP pre-application, submitted on July 19, 2024, was deemed Incomplete. In accordance with County Code 51.535(1), Republic Services had 180 days from the submission of the preapplication to submit revisions and provide additional documentation to reach Completeness. A revised application was submitted to the County on Oct. 30, 2024.

Representatives from Republic Services met with the County Planning Division in December 2024 to discuss points of clarification and additional narrative detail needed to reach Completion. Dialogue between permit applicants and the County is a standard part of the land use application process and does not occur in public meetings.

The latest application revision is now being reviewed for Completeness by County Planning Officials and an independent consultant. If it is deemed Complete, the County will provide a process timeline, public comment period, and tentative public hearing date(s) before the Benton County Planning Commission. County Code dictates that this process, including appeals, be completed within 150 days, putting the expected end date in June 2025.
