# II. APPROVE MINUTES FROM February 4, 2025 @00:03:06

Hamman moved to approve the February Minutes; Fulford seconded. The motion passed, 5-0.

## III. WORK SESSION – PLANNING COMMISSION 2025 PRIORITIES\* @00:05:15

The Planning Commission agreed to modify its priorities by removing telecom planning and countywide communications. Discussion confirmed emphasis on housing affordability and availability, Comprehensive Plan updates, and code revisions. There was interest in supporting solid waste and environmental planning efforts, contingent on direction from the Board of Commissioners (BOC). Finally, while the Planning Commission does not need to mirror the BOC's goals exactly, it was emphasized that alignment and input based on community needs are important.

# IV. WORK SESSION – DISCUSSION ON PROCESS FOR PUBLIC HEARING: LU-24-027 CONDITIONAL USE PERMIT FOR REPUBLIC SERVICES' APPLICATION FOR COFFIN BUTTE LANDFILL @00:43:06

Several actions were noted:

- 1. Makepeace to add a sentence to the planning commission script asking if anyone wishes to challenge the objectivity of any member of the planning commission.
- 2. Makepeace and Schuetz to determine process to sign up to offer testimony and how to manage multiple evenings of public testimony sign-ups.
- 3. Makepeace to explore options for displaying a large countdown clock visible to public speakers.
- 4. Makepeace to arrange for an overflow room with a virtual option to watch proceedings if needed.
- 5. Planning Commissioners to email Schuetz with any information they want incorporated into the record or questions they want addressed in the staff report.
- 6. Wilson to check with the Adair city attorney about potential conflicts of interest related to the Republic Services application.

#### V. PLANNING COMMISSIONER | STAFF UPDATES @01:55:44

The first event for the comprehensive plan update community outreach is set for March 17, 2025, and the group discussed beginning promotion immediately. It was noted that the website for the Comprehensive Plan went live the prior weekend, though engagement dates are still being finalized. Biscoe requested a shareable documents version of engagement dates and tools to help distribute information through broader networks, which Community Development confirmed would be available soon. Staff mentioned they are coordinating with the Public Information Officer and using various promotional tools such as Canva, hard copies, and digital content to support outreach. Schuetz to inform Bush about creating a shareable document with engagement dates for all areas for the Comprehensive Plan update.
